The verification must state the Commonwealth has thoroughly reviewed its files and the discovery produced is in compliance with this court's April 28, 2017 discovery order, Pa.R.Crim.P. 575(B)(3)(d) and 18 Pa. Cons. Stat. § 4904. The Commonwealth has 15 days from the entry of this order to produce discovery in this verified format. The date for producing discovery is on or before Friday, July 7, 2017. The failure of the Commonwealth to adhere to this order may result in sanctions. It is further **ORDERED** that Petitioner has 15 days following receipt of discovery to file any amendments to his pending Post-Conviction Relief Act Petition.
