Attached is documentation of the type of retaliation I've been subjected to. This Warden wants me to just shut up about this mold situation and just die in here from complications from mold exposure.

I am pleading for your help. Please don't let another Black woman die in prison.

As you may be aware, in 2019 women prisoners at Women's Huron Valley Correctional Facility (WHV) in Ypsilanti, Michigan filed a two-count civil rights action against the Michigan Department of Corrections (Case No. 19-13442). This lawsuit alleged that Women's Huron Valley, Michigan's only women's prison, is riddled with dangerous conditions which include haphazard retrofitting, leaky roofs, inoperable windows, inadequate ventilation, and outdated heating/cooling and ventilation systems which have created a breeding ground for harmful fungi and spore-producing molds such as Ochroconis, Cladosporium, and Chaetomium and that exposure to these molds constitute cruel and inhumane punishment in violation of the Eighth Amendment to the U.S. Constitution.

Make no mistake, the women in Women's Huron Valley Correctional facility are suffering from mold exposure. In the lab reports of those women lucky enough to get an off-site medical diagnosis, "MOLD" is clearly defined as the cause of their ailments.

Mold related symptoms include: constant headaches, nosebleeds, constant fatigue, breathing disorders, nausea, diarrhea, vomiting, loss of appetite, weight loss, hair loss, skin rashes, open sores, short term memory loss, neurological disorders, swollen glands, chronic ear, sinus and bronchial infections, and pain in joints and muscles. Because of the substandard healthcare in this prison, women are not receiving the medical care necessary to address mold-related ailments.

On August 25th, 2023, federal Judge Victoria A. Roberts for the United States District Court for the Eastern District of Michigan dismissed the lawsuit brought by the women prisoners. What should shock the conscience of every citizen in the State of Michigan is what the attorneys representing the Michigan Department of Corrections stated when they stood before the Court. They said:

"There are no cases establishing a prisoner's right to be free from these molds (Ochroconis, Cladosporium, and Chaetomium), that it is not clearly established that any type of mold at WHV is sufficiently dangerous to incarcerated people, and EVEN IF IT WERE CLEARLY ESTABLISHED THAT CERTAIN MOLDS WERE DANGEROUS ENOUGH TO IMPLICATE THE EIGHTH AMENDMENT, IT IS NOT CLEARLY ESTABLISHED THAT PRISON OFFICIALS NEED TO TAKE ANY PARTICULAR ACTION TO REMEDIATE THE PRESENCE OF MOLD."

The women imprisoned at Women's Huron Valley are somebody's loved ones. We have families and friends that worry about our health and safety. The Michigan Department of Corrections DOES NOT share that concern. In their arguments before the Court they expressed NO responsibility or accountability for the mold-contaminated facility women are forced to live in. In other words, women prisoners should just shut up and die a slow, painful death in here from their mold-related illnesses.

By ANY standard of decency, this treatment is inhumane. If you wouldn't allow a dog to live in such deplorable conditions and suffer the health consequences, how can you in good conscience allow Michigan's imprisoned women to live this way.

Please use your influence to bring public awareness to this issue.

I have been subjected to unrelenting retaliation by Adm. Asst. Horton & Warden Jeremy Howard of Women's Huron Valley Correctional Facility for many months because I am the major plaintiff on the lawsuit against MDOC regarding the mold in the WHV facility that has caused detrimental health problems for me.

I will continue to send you documentation every single time this Warden retaliates against me and your failure to do anything to hold him accountable to PD 03.03.130 which expressly prohibits such retaliation can only be construed as tacit approval for him to continue and that you are deliberately indifferent to the suffering I endure because of the retaliation.

On September 21st at the Warden's Forum meeting on which I serve as committee chair for Healthcare, I discovered that I was omitted from the last healthcare committee meeting. The other prisoner representative on this committee was put on the callout to attend this meeting chaired by the Warden. It is no coincidence that I was omitted. The Warden does not want me included in any discussions at the Warden's Forum about healthcare issues involving the prisoner population because I have been vocal about the mold problem in this facility that has caused so many health problems for me and other prisoners.

According to PD 04.01.150 Section I, the Warden may remove a prisoner from the housing unit representative position if that prisoner engages in conduct that jeopardizes the custody security, or good order of the facility. I have never done any of that. What I have done is represent the wishes of the prisoners I represent and have asked the Warden at the Forum what he plans to do to address the mold problem in this facility.

I should not have to endure this retaliation for acting in my capacity as unit representative. Please address this issue. Thank you for your help.

To Whom It May Concern:

I may only be a prisoner at Women's Huron Valley Correctional Facility, but I am still entitled to be treated by medical professionals that adhere to their code of conduct for their profession. Pursuant to MDOC policy PD 03.03.130 Section G, "Prisoners are to be provided with healthcare consistent with contempoary standards of medical practice in the community." I am not receiving this care. What I am being subjected to is cruel and unusual punishment and retaliation by a medical professional which should be held accountable to your agency for this unprofessional behavior.

Director Jones' behavior includes, but is not limited to, all of the following:

- Gavecmedical information regarding myself to Deputy Allen and Warden Howard without my permission on more than one occasion which is a HIPPA violation. I have a right to expect that my legitimate privacy be respected. Director Jones had no right to discuss medical record information or other official information or reports with unauthorized persons.
- On September 12th, it became apparent in my discussions with Director Jones, which can be verified by audio, that Jones is the one responsible for recommending to my doctor, Dr. Ellison, that my medical detail for use of a wheelchair be cancelled. I can only conclude that this was a retaliatory action in response to grievances that I have filed against WHV Healthcare.
- Director Jones, along with Dr. Ellison, were insistent that I meet with a Mental Health therapist, claiming that my allegations about the mold being the cause of my severe infections are "all in my head". Director Jones assertion that I am "crazy" came only after I had documented lab results that my severe medical condition IS caused by "MOLD". This is a a deliberate attempt to discredit me because my allegations about the mold do not fit the narrative that Healthcare and the Warden are putting forth.

- Director Jones cancelled the off-site appointment that was scheduled by Kenneth D. Rosenman as a follow up to the diagnosis that he made about the mold exposure in this prison environment as it relates to the severe medical conditions/infections I suffer from. There was no explanation for the cancellation. I can only assume that Director Jones does not want any further confirmation from Dr. Rosenman that mold is the cause for my ailments.
- Director Jones has denied my family access to my medical records both in print and verbally even though she possesses the signed consent form from me authorizing release of this information. My family is entitled to this medical information. Director Jones stated that she "wasn't going to give them anything".

There is no question that Director Jones is engaging in behavior that is unbecoming a member of the medical community. I am respectfully requesting that a formal investigation be opened. Thank you for your assistance in this matter.

- At the Warden's Forum when I stood up and asked the Warden what is being done to address the mold at WHV, he told me to "shut up" & sit down because "there is no mold in this facility".
- HUM Jones said she listens in on all my phone calls and Dr. Ellison told me that he watches me on the camera.
- Sargeant Stone ordered me to go to my room for two hours when I said I was going to contact the Governor about the mold.
- The Warden's Assistant, Mr. Horton, ordered me to stay in a room at the Control Center for 4-1/2 which resulted in me missing the opportunity to talk to my attorney David Steingold.
- Inspector Chapman took away my phone calls to my imprisoned brother which have been allowed for years. I was on restriction for 21 days.
- Sunday, September 10th at 3:50 in the morning, I was told to "pack up all your things" and report to Healthcare because they said I had "Covid symptoms" even though they know perfectly well that I DO NOT HAVE COVID SYMPTOMS. My ailments over many years are a result of mold exposure, as documented in 3 Lab reports.
- My JPay and incoming US mail takes WEEKS to reach me.
- Food Service personnel repeatedly threaten to take away the "special diet" meals that I need.
- Healthcare Dr. Ellison referred me to Mental Health, insinuating that I am crazy and that these symptoms of mold exposure which have ravished my body are "all in my head". It is funny that I wasn't "crazy" UNTIL I received the 3 lab reports documenting that I do in fact suffer health consequences from MOLD.

This ongoing retaliation is violative of MDOC policy and a deliberate attempt to silence my voice, prevent me from contacting attorneys, family, and advocates who can help address the mold and resulting health problems and that I and other prisoners are suffering from, and is unconscionable.

Internal Affairs has a responsibility to address prisoner complaints of retaliation against prisoners. I am respectfully requesting that you open a formal investigation. Failure to do so is tacit approval for the WHV Warden and his administration to continue to subject prisoners to retaliation.

Thank you for your assistance in my plea for help.
