# Letter to Podcast

for the past 6 months i have Been in a Federal Holding facility Located in Leitchfield, Ky Because of some pending Federal Charges.

these 6 months has Been Hell for me, this Facility Does Not <sup>have</sup> any Mental Health Doctors or Staff that i can talk to or Vent to When i am Depressed, the only thing this Jail Knows how to do is Put People on Suicide Watch Without seeing a Mental Health Professional.

there has Been Many of nights that i have had to go to Bed at night Crying myself to Sleep Because i have nobody to talk to.

a few months ago Back in January, one of the Deputy's in the Jail Referred to me as a "Fxxking Queer", When i filed a Grievance

the Jail Administration Did not take it to seriously only saying they spoke with this Deputy and did not take any Action, if Inmates are to Be held

Accountable for their Behaviour, Why Are Officers, Staff Members Not held to the same Standards?

a few Weeks after i filed my Complaint, the

Jail Allowed this Deputy to Continue to work the unit that im on.

once Again, march 28<sup>th</sup> 2024 there was

Another incident with this same Deputy, after i ate dinner i asked this Deputy to use the inmate phone and out of Retaliation from the first Grievance he said "it sucks to Be you" i asked him "What Did he say" and he Repeated it again "it sucks to Be you". i asked for a Supervisor

2 seperate times and he Blantly ignored me. i have a Bestfriend, ~~a~~ Mentow,

and Emotional Supporter at the Prison i came from Wabash Valley Corr Facility, he is known as "Part of the Pendleton two," Christopher <sup>Naeem</sup> ~~the~~ Trotter

it makes me Bummed out that im not able to vent to him But hopefully i will see him

Again, Thank you Chris. i was Recently informed By a few Deputy's that there is a (Non-Existing Policy) that is a Verbal ~~Bad~~ Practice

amongst Staff and Officers, in there training that they Are Directed to Never Refer to trans

inmates as Women or Females, Because it makes their Dept Look BAD.

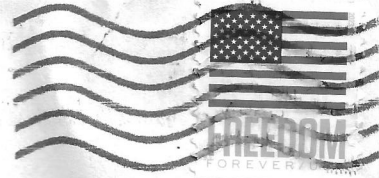
