Foremost I would like to thank you all from the bottom of my heart, for your work and all you do to help those forgotten in incarceration.

I have mailed you the Paper you requested along with a few others proving my situation.

These are 2 Lethal Force Reports from 2 separate officers. I was shot as you will see, by a black officer (P.1. Police 1) page 1.) And the white officer Koziara clearly states in his internal Affairs Lethal Force report, that I was not aggressive or threatening in any way. NO gun was ever found on my person or recovered near my person. Crime Lab reports show NO fingerprints of mines on any weapon. The white cop Koziara was silenced. The police never used him as a witness in court at preliminary EXAM. I didn't get this report until 2 years later. The Wayne County Courts are continually hiding discovery items from me. I explained on the phone that the police never booked me into jail, I was moved from the hospital and placed in an unknown facility without any warrant or detainer. I still am yet to see one. What's going on???



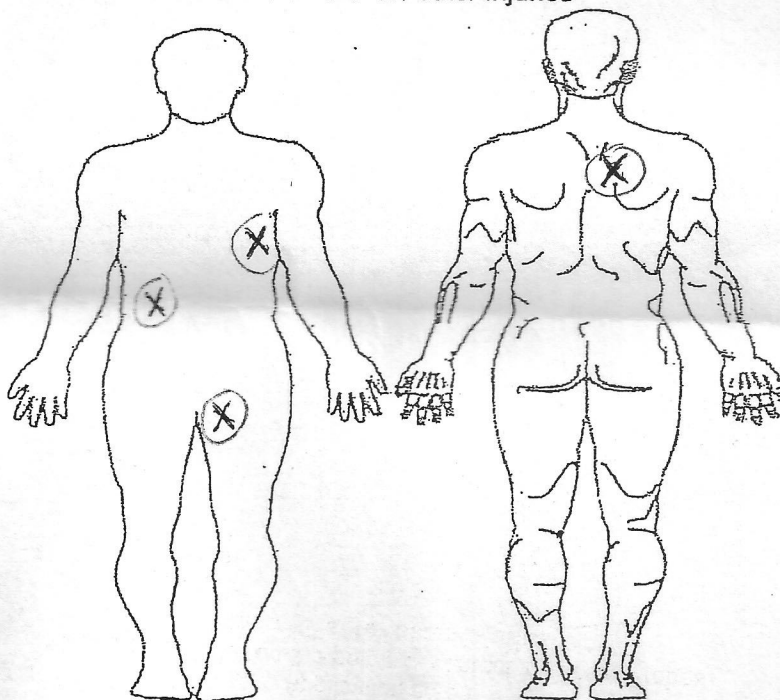
