AFFIDAVIT OF CHARLES KEVIN NATIONS

I, Charles Kevin Nations, after being duly sworn, depose and state the following:

1. I am over the age of twenty-one and competent to give this affidavit and to testify regarding the matters in this affidavit.
2. I am a Natchez native. I worked for the Natchez Police Department from 1989 to 2005.
3. In 1992, I was one of the officers who responded to the scene of the Day murder. Prior to the crime, I did not know anything about Joseph Brown although I knew of Rachel Walker, primarily because she and her friend ViFran Carter used to steal all the time. I arrested Rachel multiple times.
4. I also remember the house fire on Garden Street at the home of Moses "Nick" Green. I was parked in the vicinity of Garden Street talking to fellow officer Willie B. Jones when I saw the flames from my patrol car. I proceeded to the area. I remember getting to the scene and seeing the entire home engulfed in flames. Some of the neighbors thought that the home owner, Nick Green, was inside the home. I don't recall seeing Joseph Brown or Rachel Walker at the scene of the fire.
5. I am 100% sure that Robert Dawson was sleeping with Rachel Walker back then. Dawson earned the nickname "Dog" because he would sleep with anything. Dawson's relationship with Rachel goes way back to before Dawson was married to his now deceased wife. I don't recall if William Mitchell was involved in a relationship with Rachel, but I wouldn't put anything past Mitchell because he was a sloppy drunk. Mitchell was known for being an alcoholic and would occasionally show up at crime scenes drunk.

 The Natchez Police Department had its fair share of corruption. I recall a time when Willie B. Jones tried to get me to file a false police report stating that Willie's home had been burglarized. I declined to file the false report, but I believe another officer did. Also, Willie would steal from homes that we were called to. Multiple officers from that time have been convicted of crimes.
7. In 2005, I began working for the Adams County Sheriff's Department. Shortly after, I was appointed Administrator of the Adams County Juvenile Justice Center. I was convicted of embezzlement in 2015 and have been incarcerated for about two years. I have acknowledged that I was wrong for what I did and am committed to doing the right thing, including paying restitution once I am released.
8. I give this affidavit freely and voluntarily and have not been promised anything in return for my statement.

AFFIDAVIT OF SHARON GRINNELL

Sharon Grinnell, after being duly sworn, depose and state the following:

1. I am over the age of twenty-one (21) and am competent to give this affidavit and to testify regarding the matters in this affidavit.
2. In 1992, I was friends with Joseph Brown and his girlfriend at the time, Rachel Walker.
3. I was really good friends with Rachel back then. She and I would sometimes steal together. Rachel had a really bad shoplifting habit. Rachel was also a liar. She lied then, and she still lies now. I also know that she was cheating on Joseph. While they were dating, she also was going with "No Neck Dan."
4. Around the time of the Martha Day murder, Rachel was friends with several law enforcement officers, including Easton, Mitchell, and Sims. I was with Rachel several times when she stole for Easton, Mitchell, and Sims. There were also many times when I sat in the car while Rachel went into Mitchell's house while his wife and children were not home. Rachel had been dealing with those officers for over 10 years. When she would get in trouble, they would get her out of trouble.
5. I believe that Rachel had something to do with the Martha Day murder and the death of Nick Green. Rachel had dealings with Mr. Green. She used to be at Mr. Green's house all the time leading up to Mr. Green's death. Mr. Green didn't let people in his house if he didn't know them, and at that time, Rachel was one of the few people that he would let in. I was with Rachel one day when she went over to Mr. Green's house, but I did not go in. Rachel went to the store for Mr. Green that day.
6. Prior to trial, I was not interviewed by any of Joseph Brown's lawyers or anyone who was helping to defend him.

Last summer, after I talked to people from the Mississippi Office of Capital Post-Conviction Counsel, my sister Sherry told Rachel that I had talked to some people about Joseph's case. Rachel called me on the phone, threatened me for talking to Joseph's defense team, and told me that it was my fault that she went to jail the first time because I told the truth about her having the gun that night.

I testified at trial. If I had been asked, I would have testified to the information contained in this affidavit.



AFFIDAVIT OF VI FRAN CARTER

I, ViFran Carter, after being duly sworn, depose and state the following:

1. I am over the age of twenty-one and competent to give this affidavit and to testify regarding the matters in this affidavit.
2. In the 1980s and 90s, Rachel Walker and I would shoplift from stores in Natchez, Mississippi. To avoid arrest or get out of jail, Rachel and I would have sex with some of the Natchez Police Department officers. Rachel and I often had sex with Detective Robert Dawson and Lieutenant William Mitchell. Rachel also often had sex with Officer Charlie Sims.
3. Detective Dawson had an unmarked police car that he would ride Rachel around in. Sometimes he would pick Rachel and me up in the unmarked car. Sometimes I would be present when Rachel and Dawson had sex.
4. Rachel and I would also sell the merchandise we stole to Detective Dawson, Lieutenant Mitchell, and some of the other Natchez police officers.
5. In 1992, I was incarcerated in the Adams County Jail with Rachel Walker. While we were incarcerated, Rachel told me that Joseph did not kill Martha Day. [Rachel told me that she killed Martha Day, but before she did any time for it, she would let Joseph's "no good mother***** ass fry" for it.]
6. I had not spoken to anyone from Joseph's legal team prior to yesterday.
7. I give this affidavit freely and voluntarily and have not been promised anything in return for my statement.
